**FACILITY:** Indoor, 25 yard, six lane pool. Colorado timing system with touch pads, one button/two watch back-up, six lane electronic timing display board, and horn/strobe start. Pool depth is 12' 9" at the starting end and 3' 6" at the turning end. This pool has not been certified in accordance with 104.2.2C

**ELIGIBILITY:** Open to all swimmers currently registered with USA Swimming and Alaska Swimming. Any swimmer may swim in a senior event as long as entry limit is not exceeded.

**Entry Limit:** Swimmers are allowed 6 individual events, 2 on Friday and 4 on Saturday. Events 1-10, 43, 44 will be on Friday evening and Events 11-60 [excluding 43, 44] on Saturday.

**Entry Fees:** \$ 3.00 per swimmer  
\$ 8.00 swimmer surcharge (per swimmer)  
\$ 2.25 per individual event  
\$ 5.00 per relay

Event fees must accompany entries if mailed. Entry fees must be paid prior to the start of the meet on Friday if entries are submitted electronically.

**Entry Forms:** The list of events will be downloadable from the KSC website HYPERLINK "http://www.kachemakswim.org" [www.kachemakswim.org](http://www.kachemakswim.org) and can be imported into Team Manager. Meet Entries will be accepted in the Hy-Tek cfile cl2 format as an export from Team Manager. They may be sent on floppy disk or emailed as a zip file to [qkarndt@yahoo.com](mailto:qkarndt@yahoo.com). While electronic entries are preferable, manual entries will be accepted on the standard entry forms. Use the Consolidated Entry Sheet to group your swimmers by age and sex and be sure to use the 14 digit USA Swimming Identification Numbers. Meet Fees should be included with verification form for coaches and swimmers.

**RULES:**

1. Current USA Swimming and Alaska Swimming rules shall govern this meet.
2. This will be a pre-seeded meet.
3. All events will be timed finals.
4. Any swimmer entered in the meet, unaccompanied by a USA Swimming coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

No team or individual high point scores will be kept.

U.S.A. Swimming and A.S. warm-up guidelines will be enforced.

Swimmers may swim up to 6 (six) individual events, not more than 4 individual events on Saturday. (2 Friday and 4 Saturday)

Events may be combined. Combined events will be awarded separately by age or gender.

Special needs swimmers are encouraged to participate. Coaches should include with the team entries a copy of the Information Form for Disabled Swimmers (available on the ASI website), specifying the special needs of any adoptive swimmer(s) as well as request for non-standard entries to the attention of the Meet Director, Quniten Arndt

**Awards:** Ribbons will be awarded for 1<sup>st</sup> through 6<sup>th</sup> place.

**Housing:** Will not be provided.

**No smoking allowed on KPBSD grounds. No glass containers allowed in pool area.**

**Concessions/Hospitality:** There will be a concession stand and a hospitality room for coaches,

officials and other meet workers.

**There will be a break approximately halfway through the meet.**
